

# MORAL RIGHTS

- The artist-creator shares with the new and future owners the right to be identified as the coartist-creator of their artistic-expression or work.
- The artist-creator shares with the new and future owners the right not to have their co-artisticexpression or work falsely attributed.
- The artist-creator shares with the new and future owners the right to prevent the use of their name as the artist-creator of the work of such artistic-expression or work in the event of a distortion, mutilation, or other modification of the artistic-expression or work which would be prejudicial to the artist-creator's honor or reputation.
- The artist-creator shares with the new and future owners the right to prevent any intentional distortion, mutilation, or other modification of that work which would be prejudicial to the artistcreator's honor or reputation, and any intentional distortion, mutilation, or modification of that artistic-expression or work.
- The artist-creator shares with the new and future owners the right to prevent any destruction of the artistic-expression or work of recognized stature, and any intentional or grossly negligent destruction of that artistic-expression or work.
- The artist-creator shares with the new and future owners the right to privacy of their co-artisticexpression or work.
